This Management Discussion and Analysis (“MD&A”) of Standard Uranium Ltd. (“Standard Uranium” or the “Company”) has been prepared by management as of August 22, 2024.

This MD&A may contain “forward-looking statements” which reflect the Company’s current expectations regarding the future results of operations, performance and achievements of the Company. The Company has tried, wherever possible, to identify these forward-looking statements by, among other things, using words such as “anticipate,” “believe,” “estimate,” “expect” and similar expressions. The statements reflect the current beliefs of the management of the Company, and are based on currently available information. Accordingly, these statements are subject to known and unknown risks, uncertainties and other factors, which could cause the actual results, performance, or achievements of the Company to differ materially from those expressed in, or implied by, these statements.

Historical results of operations and trends that may be inferred from the following discussions and analysis may not necessarily indicate future results from operations.

Company Profile and Overall Performance

The Company was incorporated on November 20, 2017, under the laws of the Province of British Columbia, Canada. The common shares of the Company are listed on the TSX Venture Exchange under the trading symbol “STND”. The Company’s head office address is located at 918-1030 West Georgia Street, Vancouver, British Columbia, V6E 2Y3, Canada.

The Company’s principal business activities are the acquisition, exploration, and development of uranium exploration properties. The Company is in the process of exploring and developing its resource properties but has not yet determined whether the properties contain reserves that are economically recoverable. The Company’s flagship project is the Davidson River project, but the Company maintains other prospective exploration properties which may be considered for joint venture or sale to provide an alternative funding source and help diversify exploration risk and reduce corporate dilution.

The Company’s financial condition is affected by general market conditions and conditions specific to the mining industry. These conditions include, but are not limited to, the price of uranium and accessibility of debt or equity financing.

On June 27, 2022, the Company completed a private placement whereby the company issued 1,461,380 units at \$0.55 per unit and 3,613,169 flow-through units for \$0.65 per unit for gross proceeds of \$3,152,319. Each unit is comprised of one common share and one-half of one share purchase warrant and each flow-through unit is comprised of one flow-through common share and one-half of one share purchase warrant. Each whole warrant is exercisable to purchase one additional common share of the Company at a price of \$0.85 for a period of two years, subject to acceleration provisions. In connection with the private placement, the Company paid broker fees of \$246,119 in cash and issued 304,473 broker’s warrants. Each broker’s warrant is exercisable into one additional common share of the Company at a price of \$0.55 for a period of two years. The Company additionally incurred financing advisory and legal fees directly related to the offering in the total amount of \$77,552.

On July 14, 2022, the Company completed a private placement whereby the company issued 635,423 flow-through units for \$0.65 per unit for gross proceeds of \$413,026. Each flow-through unit is comprised of one flow-through common share and one-half of one share purchase warrant. Each whole warrant is exercisable to purchase one additional common share of the Company at a price of \$0.85 for a period of two years, subject to acceleration provisions. In connection with the private placement, the Company paid broker fees of \$26,101 in cash and issued 38,125 broker’s warrants. Each broker’s warrant is exercisable into one additional common share of the Company at a price of \$0.55 for a period of two years. The Company additionally incurred financing advisory and legal fees directly related to the offering in the total amount of \$29,289.

On September 29, 2022, the Company completed a private placement whereby the company issued 1,834,652 units at \$0.55 per unit and 1,788,880 flow-through units for \$0.65 per unit for gross proceeds of \$2,171,830. Each flow-through unit is comprised of one flow-through common share and one-half of one share purchase warrant. Each whole warrant is exercisable to purchase one additional common share of the Company at a price of \$0.85 for a period of two years, subject to acceleration provisions.

The Company allocated proceeds of \$362,353 to the common share purchase warrants using the residual value. In connection with the private placement, the Company paid broker fees of \$101,462 in cash and issued 175,357 broker's warrants with a fair value of \$31,039. Each broker's warrant is exercisable into one additional common share of the Company at a price of \$0.55 for a period of two years. The Company additionally incurred financing advisory and legal fees directly related to the offering in the total amount of \$12,437 which is included as share issuance cost.

On October 21, 2022, the Company completed a private placement whereby the company issued 150,000 units at \$0.55 per unit and 3,077,231 flow-through units for \$0.65 per unit for gross proceeds of \$2,082,700. Each flow-through unit is comprised of one flow-through common share and one-half of one share purchase warrant. Each whole warrant is exercisable to purchase one additional common share of the Company at a price of \$0.85 for a period of two years, subject to acceleration provisions.

On December 13, 2023, the Company completed a private placement, issuing an aggregate of 2,037,056 units at a price of \$0.25 ("Units") and 5,965,137 flow-through units at a price of \$0.30 ("FT Units"), for aggregate gross proceeds of \$2,298,805. On December 21, 2023, the Company closed the second tranche of the private placement whereby the company issued 1,368,340 units at \$0.25 per unit. Each Unit consists of one common share and one half of one common share purchase warrant ("Warrant"). Each FT Unit consists of one flow-through common share and one half of one Warrant. Each Warrant is exercisable at a price of \$0.45 for a period of 24-months.

In connection with the financing, the Company paid \$124,988 in cash and issued 416,859 finder's warrants. The finder's warrants are exercisable until December 13, 2025 at prices ranging from \$0.25 to \$0.45; 353,626 at \$0.25, 58,333 at \$0.30 and 4,900 at \$0.45.

The Company allocated proceeds of \$34,208 to the common share purchase warrants issued in the second tranche using the residual value method. In connection with the private placement, the Company paid broker fees of \$124,988 in cash and issued 353,626 broker's warrants with a fair value of \$57,452. Each broker's warrant is exercisable into one additional common share of the Company at a price of \$0.09 for a period of two years. The Company additionally incurred financing advisory and legal fees directly related to the offering in the total amount of \$41,353 which is included as share issuance cost.

The Company expects expenses and losses to fluctuate from period to period depending on the management's decisions to increase or decrease activities depending on significant factors including but not limited to the Company's cash position, exploration commitments, market sentiment and management assessment on the ability to raise additional funding. In addition, management will monitor expenses and activity to ensure that the Company's financial resources are best used to manage the day to day operations of the Company.

Davidson River project

Standard Uranium Holdings (Saskatchewan) Ltd. (“Standard Uranium Holdings”), a wholly owned subsidiary of the Corporation, entered into an option agreement in January 2017, which was subsequently amended in March 2018 and on May 1, 2019, to acquire an option to acquire 100% interest in the Davidson River project from the Optionors (the “Option Agreement”). Pursuant to the terms of the Option Agreement, Standard Uranium Holdings has the right to acquire an undivided 90% interest in the project (including the rights to all metals and minerals on the Property but excluding limestone, dolomite, and building stone) provided that Standard Uranium Holdings pays an aggregate of \$1,000,000 to the Optionors, as follows:

- (a) pays the sum of \$100,000 to the Optionors on the date of the Option Agreement, which amount has been paid by Standard Uranium Holdings;
- (b) on the date of, and concurrently with, the completion of a Going Public Transaction, issue 1,000,000 common shares in the capital of a company that Standard Uranium Holdings has assigned its rights and obligations to for the Going Public Transaction;
- (c) Before May 11, 2020, pays the sum of \$50,000 to the Optionors (paid);
- (d) Before May 4, 2021, pays the sum of \$75,000 to the Optionors (paid);
- (e) Before May 4, 2022, pays the sum of \$100,000 to the Optionors (paid);
- (f) Before May 4, 2023, pays the sum of \$125,000 to the Optionors (paid);
- (g) Before May 4, 2024, pays the sum of \$200,000 to the Optionors; and
- (h) Before May 4, 2025, pays the sum of \$350,000 to the Optionors.

The Option Agreement further provides Standard Uranium Holdings the right to acquire the remaining 10% interest in the project for the sum of \$10,000,000 if exercised within one year of March 1, 2018, and increased thereafter by inflation, expiring February 28, 2028. The transfer of the project to Standard Uranium Holdings under the Option Agreement is subject to the Optionors retaining a 2.5% gross overriding royalty with respect to all mineral production from the project, subject to buyback rights of Standard Uranium Holdings.

Assuming completion of the exercise of the rights under the Option Agreement, Standard Uranium Holdings will hold a 100% interest in the project, subject to the aforementioned royalty.

Standard Uranium Holdings is required to pay 100% of the expenditures related to the project. If Standard Uranium Holdings exercises the right to acquire the 90% interest in the project, Standard Uranium Holdings will continue to be required to pay 100% of the expenditures related to the project until a positive preliminary economic assessment (within the meaning of NI 43-101) has been completed which confirms that a deposit on the project contains at minimum 25 million pounds of uranium U308.

Sun Dog project

The Company holds a 100%-interest in the Sun Dog project located along the northwestern edge of the Athabasca Basin.

On October 20, 2023, the Company signed a definitive option agreement (“Sun Dog Option Agreement”) with 1443904 B.C. Ltd., which was subsequently acquired by Aero Energy Ltd. (“Aero”), pursuant to which, Aero will be granted the option to acquire 100% of the Sun Dog project by completing three years of exploration programs and a series of cash and equity payments as follows:

- (a) Year 1: Cash payment of \$200,000 (received), equity payment equal to \$200,000 (received 1,333,333 common shares of Aero with a fair value of \$200,000) and incur exploration expenditures of \$1,500,000.
- (b) Year 2: Cash payment of \$200,000, equity payment equal to \$200,000 and incur exploration expenditures of \$2,000,000.
- (c) Year 3: Cash payment of \$250,000, equity payment equal to \$250,000 and incur exploration expenditures of \$3,000,000.

Upon signing the Sun Dog Option Agreement, the Company deemed it appropriate to carry out an impairment assessment as to whether the carrying amount of the property exceeded its recoverable amount. An indicator of impairment was identified, and the recoverable amount was determined to be \$1,106,833 based on the fair value of the consideration to be received pursuant to the Sun Dog Option Agreement, using a discount rate assumption of 17%. Accordingly, an impairment expense of \$2,872,034 was recognized related to the property.

Canary project

On December 27, 2023, the Company signed a definitive option agreement with Mamba Exploration Limited (“Mamba”), pursuant to which, Mamba will be granted the option to earn a 75% interest over three years in the 7,302-hectare Canary project located in the eastern Athabasca Basin.

The Option is exercisable by Mamba in two stages. During the first stage, Mamba can earn a 50% interest by completing the following:

- Year 1: Cash payment of \$100,000 (received), equity payment equal to \$100,000 (received 3,098,938 with a fair value of \$153,005 representing \$100,000 under the agreement) and incur exploration expenditures of \$1,000,000.
- Year 2: Cash payment of \$100,000, equity payment equal to \$100,000 and incur exploration expenditures of \$2,000,000.

After earning a 50% interest in the Canary project, the second stage will commence. During the second stage, Mamba can increase its interest in the Canary project to 75% by completing a further cash payment of \$100,000, arranging for the issuance of a further \$100,000 worth of shares to the Company and incurring an additional \$3,000,000 of expenditures, all within the third year.

The Company will act as the operator of the project and is entitled to charge a 10% fee on expenditures during the first two stages.

Atlantic project

On February 20, 2024, the Company signed a definitive option agreement (“Atlantic Option Agreement”) with ATCO Mining Inc. (“ATCO”), pursuant to which, ATCO will be granted the option to earn a 75% interest in the Atlantic project by completing three years of exploration programs and a series of cash and equity payments as follows:

- Year 1: Cash payment of \$110,000 (received), equity payment of 3,000,000 common shares (received with a fair value of \$285,000) and incur exploration expenditures of \$1,300,000.
- Year 2: Cash payment of \$120,000, equity payment of 6,000,000 common shares and incur exploration expenditures of \$2,000,000.
- Year 3: Cash payment of \$200,000, equity payment of 6,000,000 common shares and incur exploration expenditures of \$3,000,000.

The Company will act as the operator of the project and is entitled to charge a 10% fee on expenditures in Year 1, increasing to 12% in Year 2 and Year 3. The Company earned an operator fee of \$103,185 during the year ended April 30, 2024.

During the year ended April 30, 2024, the Company received total option payments of \$395,000 pursuant to the Atlantic Option Agreement. This exceeded the carrying value of the project by \$257,036, which was recognized in the statement of loss and comprehensive loss.

Eastern Athabasca Basin Projects:

The Company’s portfolio includes seven additional projects in the Athabasca uranium district. The Ascent project is located in the northern portion of the eastern Athabasca Basin. Additionally, the Rocas, Corvo, Ox Lake and Cable Bay SW projects are positioned marginal to the present-day eastern boundary of the Athabasca Basin. The newly staked Harrison project is situated in the southwest Athabasca Basin, proximal to the flagship Davidson River project. The Brown Lake project is located just inside the Basin margin.

Corvo Project

On September 19, 2023, the Company issued 1,250,000 common shares to Eagle Plains Resources Ltd. to acquire eight additional claims contiguous with the Corvo project. The common shares were recorded at their fair value of \$81,250.

Results of Operations

For the years ended April 30, 2024 and 2023, the Company reported net losses before income tax of \$4,525,702 and \$1,184,980, respectively. The net loss before income taxes during the years ended April 30, 2024 and 2023 are summarized below.

The Company's net loss before income taxes for the year ended April 30, 2024 increased by \$3,340,924 when compared to the year ended April 30, 2023. The increase in loss is a result of the impairment expense recognized in the current year on the Sun Dog project. When reconciling for this, the Company's expenditures increased by \$468,890, driven by:

- Share-based compensation increased by \$138,867 due to the vesting of new and previously granted stock options.
- Consulting fees increased by \$117,992, caused by an increase in certain consulting fees in the current year.
- Settlement of flow-through premium liability decreased by \$630,781, a result of the Company incurring less exploration and evaluation expenditures in the current year.
- A loss on the change in fair the fair value of marketable securities of \$252,717, a result of adjusting the marketable securities to their market price as of April 30, 2024. The Company incurred no such expense in the prior year.

These increases were offset by the decreases to the following:

- General and administrative decreased by \$118,407 as a result of a decrease in travel, marketing and office expenditures.
- Investor relations decreased by \$161,301 due to decreased investor relations and marketing initiatives in the current period.
- Operator fee income of \$103,185 and option payments received of \$257,036 earned pursuant to the option agreement with ATCO on the Atlantic property. The Company incurred no such income in the prior year.

In Q4 2024, the Company recognized an impairment loss of \$2,872,034 on the Sun Dog property.

In Q1 to Q3 2024, the Company reduced exploration and evaluation spending, resulting in a decreased settlement of the flow-through premium liability, resulting in the larger loss for the period.

In Q3 2023, the Company issued stock options and RSUs, resulting in share-based compensation expense of \$100,714, resulting in the larger loss for the period.

In Q4 2022, the Company issued stock options resulting in share-based compensation expense of \$272,645 and recognized a deferred income tax expense of \$643,000, resulting in the larger loss for the period.

Liquidity and Capital Resources

The Company reported working capital of \$605,602 at April 30, 2024 compared to a working capital deficit of \$439,627 as at April 30, 2023. As at April 30, 2024, the Company had cash on hand of \$555,912 (April 30, 2023 - \$28,029).

Current liabilities as at April 30, 2024 consist of accounts payable and accrued liabilities of \$291,572 (April 30, 2023 - \$697,197), advances from joint venture partners of \$10,463 (2023 - \$Nil), and the flow-through share premium liability of \$243,736 (April 30, 2023 - \$106,336).

Off-Balance Sheet Arrangements

The Company does not utilize off-balance sheet arrangements.

Transactions with Related Parties

Unless otherwise noted, related party transactions were incurred in the normal course of operations and are measured at the exchange amount, being the amount established and agreed upon by the related parties.

During the year ended April 30, 2024, the Company incurred share-based compensation of \$296,851 (2023: \$123,304) for options and RSUs granted to officers and directors of the Company.

During the year ended April 30, 2024, the Company incurred director's fees of \$114,000 (2023: \$83,333).

As of April 30, 2024, there was \$18,953 (April 30, 2023: \$60,333) owing to companies controlled by certain officers and directors of the Company. The amounts owing are unsecured, non-interest bearing, have no fixed terms of repayment and are due on demand. The Company has also prepaid expenses of \$10,500 (April 30, 2023: \$5,850) to certain officers of the Company in connection with expenses to be incurred on behalf of the Company or services to be provided to the Company.

The increased net loss is a result of the impairment expense recognized on the Sun Dog project, the decreased settlement of the flow-through share premium and an increase to consulting fees, as discussed above under "Results of Operations".

Few exploration projects successfully achieve development stage, due to factors that cannot be predicted or anticipated, and even one such factor may result in the economic viability of a project being detrimentally impacted such that it is neither feasible nor practical to proceed. The Company closely monitors its activities and those factors that could impact them and employs experienced consultants to assist in its risk management and to make timely adequate decisions. Environmental laws and regulations could also impact the viability of a project. The Company has ensured that it has complied with these regulations, but there can be changes in legislation outside the Company's control that could also add a risk factor to a project.

Risks and Uncertainties

The Company's business remains mineral property acquisition, exploration and development business and as a result it may be exposed to a number of operational, financial, regulatory and other risks and uncertainties that are typical in the natural resource industry and common to other companies in the exploration and development stage. These risks may not be the only risks faced by the Company. Additional risks and uncertainties not presently known by the Company or which are presently considered immaterial could adversely impact the Company's business, results of operations, and financial performance in future periods.

Need for Additional Funding

Further funding may be required by the Company to continue as a going concern. There is no guarantee that the Company will be able to raise sufficient funds. In addition, any future financing may be dilutive to existing shareholders of the Company. Many factors influence the Company's ability to raise funds, including the health of the capital markets, the climate for mineral exploration investment and the Company's track record. Actual funding requirements may vary from those planned due to a number of factors, including the acquisition of new projects. Management is continually assessing the Company's cash needs and potential sources of financing but recognizes there may be some difficulty obtaining such financing due to the current market conditions. There is no guarantee that the Company will be able to secure additional financing in the future at terms that are favorable, or at all.

Share Price Fluctuations

Securities markets have at times in the past experienced a high degree of price and volume volatility, and the market price of securities of many companies, particularly those considered to be exploration stage companies such as the Company, have experienced wide fluctuations in share prices which have not necessarily been related to their operating performance, underlying asset values or prospects. There can be no assurance that these kinds of share price fluctuations will not occur in the future, and if they do occur, how severe the impact may be on the Company's ability to raise additional funds through equity issues.

Exploration Stage Risks

Exploration for mineral resources involves a high degree of risk, the cost of conducting programs may be substantial and the likelihood of success is difficult to assess.

Resource exploration and development is a highly speculative business, characterized by a number of significant risks including, but not limited to, unprofitable efforts resulting not only from the failure to discover mineral deposits but also from finding mineral deposits that, though present, are insufficient in quantity and quality to return a profit from production. Few exploration projects successfully achieve development due to factors that cannot be predicted or anticipated, and even one such factor may result in the economic viability of a project being detrimentally impacted such that it is neither feasible nor practical to proceed. The Company closely monitors its activities and those factors that could negatively impact it and employs experienced consultants and key management to assist in its risk management and to make timely decisions regarding future property expenditures.

Other risks associated with projects in the exploration and development stage which could cause delays or prohibit the progress of the overall project include delays in obtaining required government approvals and permits and the inability to obtain suitable or adequate machinery, equipment, road access, power or labour.

No Known Mineral Reserves or Mineral Resources

There are no known bodies of commercial minerals on the Company's mineral properties. The exploration programs undertaken and proposed constitute an exploratory search for mineral resources and mineral reserves or programs to

qualify identified mineralization as mineral reserves. There is no assurance that the Company will be successful in its search for mineral resources and mineral reserves.

Metal Price Risk

The Company is exposed to commodity price risk. Declines in the market price of uranium and other minerals may adversely affect the Company's ability to raise capital in order to fund its ongoing operations. Commodity price declines could also reduce the amount the Company would receive on the disposition of any of its mineral property interests to a third party.

Operating Hazards and Risks

The Company's operations are subject to hazards and risks normally associated with the exploration of mineral properties, any of which could cause delays in the progress of the Company's exploration plans, damage to or destruction of property, loss of life and/or environmental damage. Some of these risks include, but are not limited to, unexpected or unusual geological formations; rock bursts, cave-ins, fires, flooding and earthquakes; unanticipated changes in metallurgical characteristics and mineral recovery, unanticipated ground or water conditions, industrial or labour disputes, hazardous weather conditions, cost overruns, land claims and other unforeseen events may occur. A combination of experience, knowledge and careful evaluation may not be able to overcome these risks.

The nature of these risks is such that liabilities might exceed any insurance policy limits, the liabilities and hazards might not be insurable or the Company might not elect to insure itself against such liabilities due to high premium costs or other factors. Such liabilities may have a materially adverse effect on the Company's financial condition and operations and could reduce or eliminate any future profitability and result in increased costs and a decline in the value of the securities of the Company.

Environmental Risk

The Company seeks to operate within environmental protection standards that meet or exceed existing requirements in the country in which the Company operates. Present or future laws and regulations and third party opposition, however, may affect the Company's operations. Future environmental costs may increase due to changing requirements or costs associated with exploring, developing, operating and closing of mines. Programs may also be delayed or prohibited in certain areas. The costs of complying with changes in governmental regulations can negatively impact the Company's financial performance.

Reliance on Key Personnel

The success of the Company's operations and activities is dependent to a significant extent on the efforts and abilities of its senior management team, as well as outside contractors, experts and its partners. The loss of one or more members of senior management, key employees, contractors or partners, if not replaced, could have a material adverse effect on the Company's business, results of operations and financial performance.

Conflicts of Interest

The Company's directors and officers may serve as directors or officers, or may be associated with, other reporting companies, or have significant shareholdings in other companies. To the extent that such other companies may participate in business or asset acquisitions, dispositions, or ventures in which the Company may participate, the directors and officers of the Company may have a conflict of interest in negotiating and concluding on terms with respect to the transaction. If a conflict of interest arises, the Company will follow the provisions of the BC *Business Corporations Act* ("BCBCA") dealing with conflict of interest. These provisions state that where a director has such a conflict, that director must, at a meeting of the Company's directors, disclose his or her interest and refrain from voting on the matter unless otherwise permitted by the BCBCA. In accordance with the laws of the Province of British Columbia, the directors and officers of Standard Uranium Ltd. are required to act honestly, in good faith, and in the best interest of Standard Uranium Ltd.

Substantial Expenditures Are Required

Substantial expenditures are required to establish mineral reserves through drilling and the estimation of mineral reserves or mineral resources in accordance with the CIM Definition Standards. Although significant benefits may be derived from the discovery of a major mineralized deposit, the Company may not discover minerals in sufficient quantities or grades to justify a commercial mining operation and the funds required for development may not be obtained on a timely basis or may not be obtainable on terms acceptable to the Company. Estimates of mineral reserves and mineral resources can also be affected by environmental factors, unforeseen technical difficulties and unusual or unexpected geological formations. In addition, the grades of minerals ultimately mined may differ from those indicated by drilling results. Material changes in mineral reserve or mineral resource estimates, grades, stripping ratios or recovery rates may affect the economic viability of any project.

Inaccurate Estimates

Unless otherwise indicated, mineralization figures presented by the Company in filings with securities regulatory authorities, press releases and other public statements that may be made from time to time, are based upon estimates made by Company personnel and independent geologists. These estimates are inherently imprecise, as they depend upon geological interpretation and statistical inferences drawn from drilling and sampling analysis, which may prove to be unreliable. As a result, there can be no assurance that mineral resource or other mineralization figures or estimates of costs (including initial capital costs and initial capital intensity) and expenses will be accurate, nor that the resource mineralization could be mined or processed profitably.

Governmental Regulation

The Company's assets and activities are subject to extensive Canadian federal, provincial, territorial and local laws and regulations governing various matters, including, but not limited to: land access, use and ownership; water use; environmental protection; social consultation and investment; management and use of toxic substances and explosives; rights over and management of natural resources, including minerals and water; prospection, exploration, development and construction of mines, production and reclamation; exports and imports; taxation; mining royalties; importation of equipment and goods; transportation; hiring practices and labour standards by the Company and contractors, as well as occupational health and safety, including mine safety; reporting requirements related to investment, social and environmental impacts, health and safety, and other matters; processes for preventing, controlling or halting artisanal or illegal mining activities; and historic and cultural preservation.

The costs and efforts associated with compliance with laws and regulations are already substantial and future laws and regulations, changes to existing laws and regulations or more stringent application and enforcement of current laws and regulations by governmental authorities, could cause additional expenses, capital expenditures, delays in the development of the Company's property, and even restrictions on or suspensions of Company operations. Moreover, these laws and regulations may allow governmental authorities and private parties to bring complaints or lawsuits against the Company based upon alleged damage to property and/or injury to persons resulting from the environmental, health and safety impacts of the Company's past and current operations, or possibly even actions or inaction by parties from whom the Company acquired its property, and could lead to the imposition of substantial financial judgments, fines, penalties or other civil or criminal sanctions.

It is challenging to comply strictly with all of the norms that apply to the Company. The Company retains competent and trained staff, professionals, attorneys and consultants in jurisdictions in which it does business; however, there is no certainty that both it and its contractors will continuously be compliant with all applicable laws and regulations. The failure to comply with all applicable norms could lead to financial restatements, fines, penalties and other material negative impacts on the Company.

Competitive Conditions

The Company will actively compete for resource acquisitions, exploration leases, licenses, concessions, and skilled industry personnel with a substantial number of other mining companies, many of which have significantly greater financial resources than the Company. The Company's competitors will include major integrated mining companies and numerous other independent mining companies and individual producers and operators, some of which may have greater liquidity, greater access to credit and other financial resources, newer or more efficient equipment, lower cost

structures, more effective risk management policies and procedures and/or greater ability than the Company to withstand losses. The Company's competitors may be able to respond more quickly to new laws or regulations or emerging technologies or devote greater resources to the expansion of their operations than the Company can. In addition, current and potential competitors may make strategic acquisitions or establish cooperative relationships among themselves or with third parties. Competition could adversely affect the Company's ability to acquire suitable new properties in the future. Competition could also affect the Company's ability to raise financing to fund the exploration and development of its properties or to hire qualified personnel. The Company may not be able to compete successfully against current and future competitors, and any failure to do so could have a material adverse effect on the Company's business, financial condition or results of operations.

Political Regulatory Risks

Any changes in government policy may result in changes to laws affecting ownership of assets, exploration policies, monetary policies, taxation, rates of exchange, environmental regulations, labour relations and return of capital. This may affect both the Company's ability to undertake exploration and development activities in respect of present and future properties in the manner currently contemplated, as well as its ability to continue to explore, develop and operate those properties in which it has an interest or in respect of which it has obtained exploration and development rights to date. The possibility that future governments may adopt substantially different policies, which might extend to expropriation of assets, cannot be ruled out.

Acquisitions and Joint Ventures

From time to time the Company will evaluate opportunities to acquire or enter into joint ventures in respect of mining assets and businesses. These acquisitions and joint ventures may be significant in size, may involve granting rights to third parties, may change the scale of the Company's business and may expose it to new geographic, political, operating, financial and geological risks. The Company's success in its acquisition and joint venture activities will depend on its ability to successfully negotiate arrangements, identify suitable acquisition and joint venture candidates and partners, acquire or enter into a joint venture with them on acceptable terms and integrate their operations successfully with those of the Company.

Any acquisitions or joint ventures would be accompanied by risks, such as the difficulty of assimilating the operations and personnel of any acquired companies; the potential disruption of the Company's ongoing business; the inability of management to maximize the financial and strategic position of the Company through the successful incorporation of acquired assets and businesses or joint ventures; additional expenses associated with amortization of acquired intangible assets; the maintenance of uniform standards, controls, procedures and policies; the impairment of relationships with employees, customers and contractors as a result of any integration of new management personnel; dilution of the Company's present shareholders or of its interests in its subsidiaries or assets as a result of the issuance of shares to pay for acquisitions or the decision to grant earning or other interests to a joint venture partner; and the potential unknown liabilities associated with acquired assets and businesses. There can be no assurance that the Company would be successful in overcoming these risks or any other problems encountered in connection with such acquisitions or joint ventures. There may be no right for shareholders to evaluate the merits or risks of any future acquisition or joint venture undertaken except as required by applicable laws and regulations.

Infrastructure

Exploration, development and processing activities depend on adequate infrastructure. Reliable roads, bridges, power sources and water supply are important elements of infrastructure, which affect access, capital and operating costs. The lack of availability on acceptable terms or the delay in the availability of any one or more of these items could prevent or delay the exploration or development of the Company's mineral properties. If adequate infrastructure is not available in a timely manner, there can be no assurance that the exploration or development of the Company's mineral properties will be commenced or completed on a timely basis, if at all. Furthermore, unusual or infrequent weather phenomena, sabotage, government or other interference in the maintenance or provision of necessary infrastructure could adversely affect our operations. Failure to adequately meet these infrastructure requirements or changes in the cost of such requirements could affect the Company's ability to carry out exploration and future development operations and could have a material adverse effect on the Company's business, financial condition, results of operations, cash flows or prospects.

Claims and Legal Proceedings

The Company and/or its directors and officers may be subject to a variety of civil or other legal proceedings, with or without merit. From time to time in the ordinary course of its business, the Company may become involved in various legal proceedings, including commercial, employment and other litigation and claims, as well as governmental and other regulatory investigations and proceedings. Such matters can be time-consuming, divert management's attention and resources and cause the Company to incur significant expenses. Furthermore, because litigation is inherently unpredictable, the results of any such actions may have a material adverse effect on the Company's business, operating results or financial condition.

Going Concern Risk

The Financial Statements have been prepared on a going concern basis under which an entity is considered to be able to realize its assets and satisfy its liabilities in the ordinary course of business. The assessment of the Company's ability to continue as a going concern and to raise sufficient funds to pay for its ongoing operating expenditures and meet its liabilities for the ensuing year involves significant judgment based on historical experience and other factors, including expectation of future events that are believed to be reasonable under the circumstances. The Company's future operations are dependent upon the identification and successful completion of equity or debt financing and the achievement of profitable operations at an indeterminate time in the future. There can be no assurances that the Company will be successful in completing equity or debt financing or in achieving profitability.

Information Systems and Cyber Security

The Company's operations depend on information technology ("IT") systems. These IT systems could be subject to network disruptions caused by a variety of sources, including computer viruses, security breaches and cyber-attacks, as well as disruptions resulting from incidents such as cable cuts, damage to physical plants, natural disasters, terrorism, fire, power loss, vandalism and theft.
